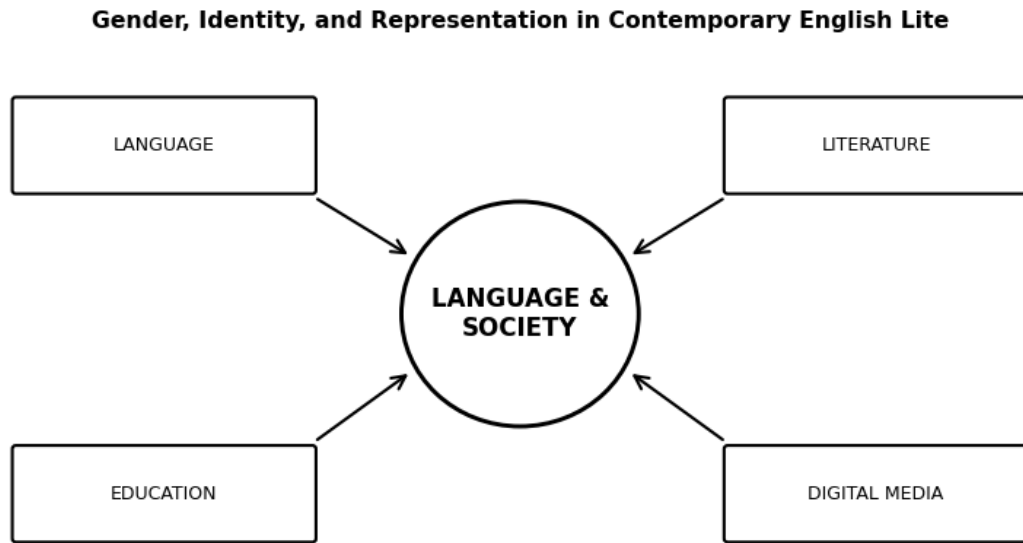


Figure 6. Simplified conceptual framework for Gender, Identity, and Representation in Contemporary English Literature.
