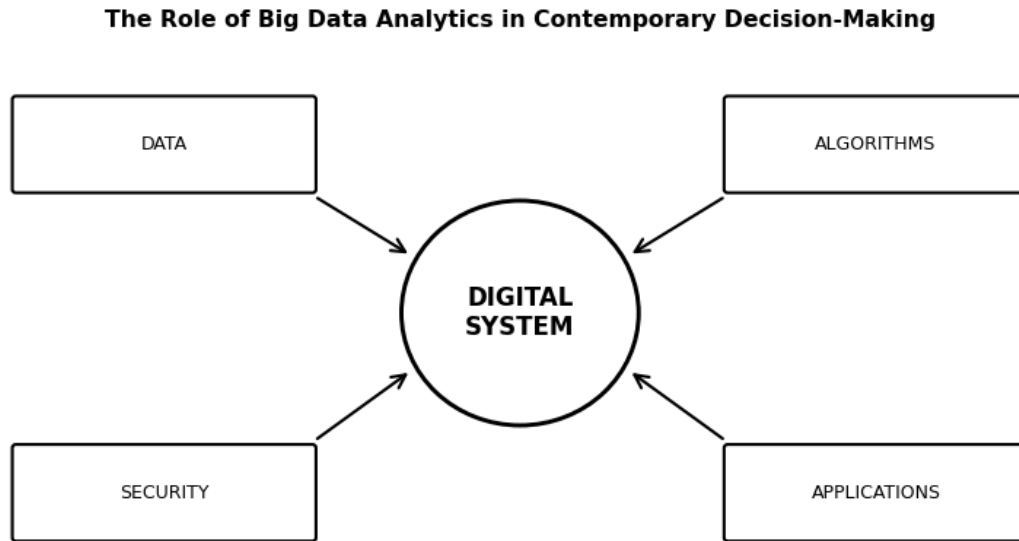


Figure 20. Simplified conceptual framework for The Role of Big Data Analytics in Contemporary Decision-Making.
